## **Deer Management Regulations**

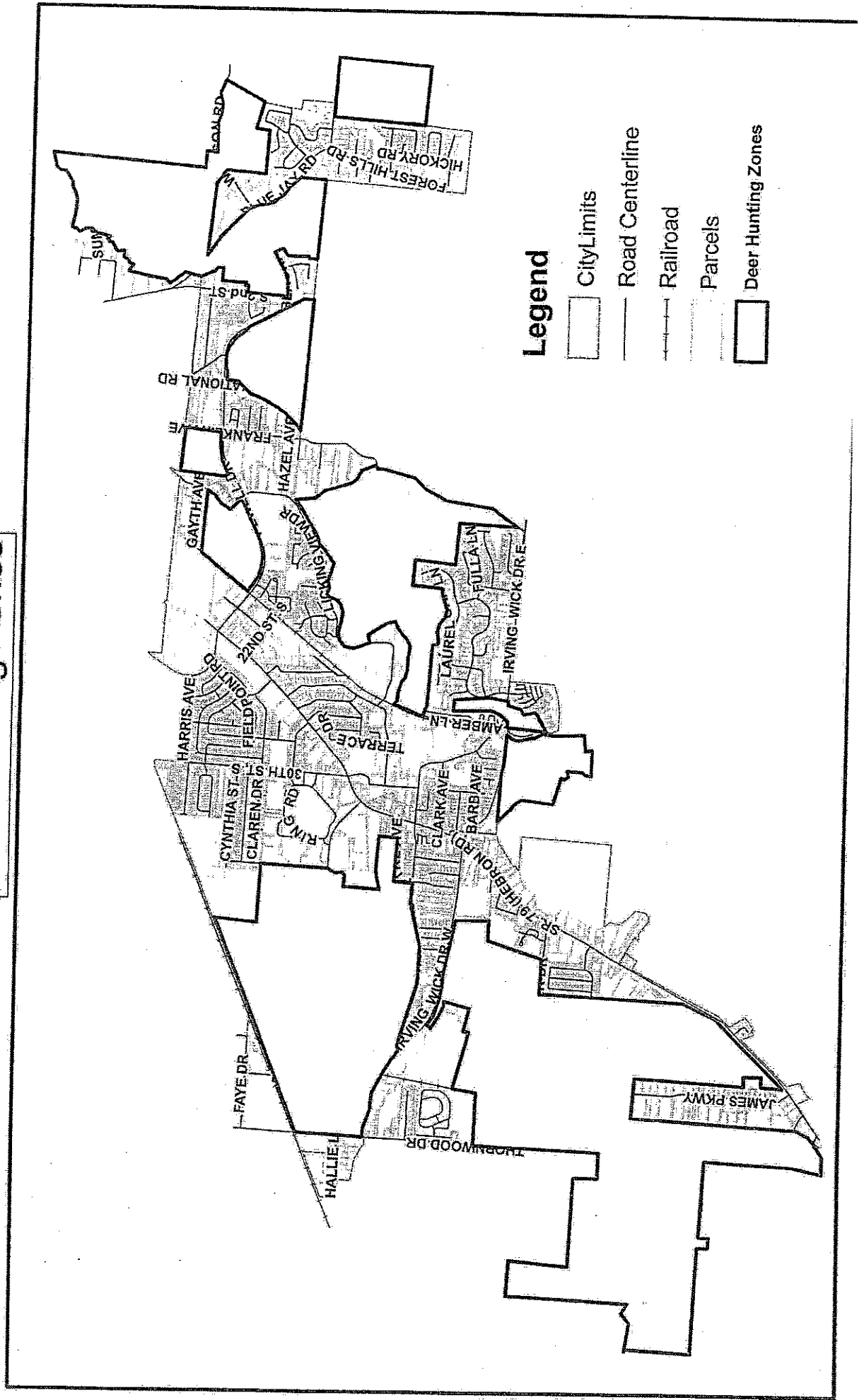
### General Regulations

1. Hunting must be done in compliance with State of Ohio hunting and trapping regulations. Hunters must pass a skill qualification test at Broken Arrow.
2. The use of crossbows and compound bows is allowed. Firearms and other types of hunting apparatus are prohibited.
3. Heath's bow hunting season is concurrent with the State of Ohio bow hunting season.
4. Every hunter must be registered with the Heath Police Department.
5. Written authorization of the property owner must be obtained and in possession of the hunter when on that property.
6. Hunting is allowed only in pre-approved areas identified by City officials.
7. The hunter is required to remove the entire deer after a kill. No portions of the carcass are to be left behind unless the property owner allows otherwise.
8. Deer must not be bled or dressed within view of the general population.
9. Portable tree stands, which must be removed upon permit expiration, may be used with the approval of the property owner.
10. The Heath Police Department must be contacted prior to beginning and at the end of the hunt if hunting on City property.
11. Harvested deer must be viewed and tagged by the Heath Police Department for count and gender verification. Only deer harvested in Heath will be tagged by the Heath Police Department.
12. Hunting of antlered deer is strongly discouraged.
13. Hunting of albino or piebald deer is prohibited.

### Protection of the General Population

1. When within 200 feet of a residence, shots must not be taken in the direction of the residence.
2. The use of tree stands is encouraged.
3. Hunters under the age of 18 must meet all the qualifications of adult hunters and must be accompanied by an adult over 21 years of age.

**Saturday, September 5, 2009** Lottery drawing for controlled hunt in Forry Preserve at Heath Municipal Building. Registration starts at 9:00 AM. Drawing at 9:30 AM.

### FORRY PRESERVE

The lottery drawing will allow a maximum of three hunters to harvest deer in the Forry Preserve. Hunters drawn will select a two week segment that they wish to hunt in the order that they are drawn. When the calendar is filled the drawing will end. If the calendar year for deer season is not filled the names of hunters in the drawing will be re-drawn. Also if a hunter notifies the City of Heath that he cannot hunt in the two weeks that he selected it will be filled from a list maintained by the City of Heath. Hunters who wish to be in the lottery that cannot be at drawing can send a representative if they are already registered with the City of Heath to participate in the deer management program.
