## Port Authority plans set for "D.C. Fly-In 2008" for April 30

Local Public, Private Officials to Meet with Ohio Congressional Delegation

For the second year in a row, the Heath-Newark-Licking County Port Authority will host a contingent of local public and private officials meeting with members of the Ohio delegation to Congress in Washington, D.C. This year's "D.C. Fly-In" as it is dubbed, will take place Wednesday, April 30.

The contingent will meet with U.S. Senator Sherrod Brown, U.S. Representative Zack Space, and U.S. Representative Pat Tiberi in their respective Capitol Hill offices. A briefing with legislative staff of the Ohio congressional delegation is also scheduled along with a meeting with staff for U.S. Senator George Voinovich.

An 11-person contingent is scheduled to make the trip which Heath American is set for flying in and out in the same day. Officials from major employers at The Base-Boeing, Bionetics, and Atlantic Inertial Systems—are attending along with local leaders. Expected to make the fly-in are Licking County Commissioners Tim Bubb, Doug Smith, and Mark Van Buren; Heath Mayor Richard Waugh; Licking County Chamber of Commerce President Cheri Hottinger, Heath-Newark-Licking County Port Authority Board Member Fred Paul; Port Authority Executive Director Rick Platt and Operations Assistant Bill Wright.


